(Training script revised 17 January 2011- Revision B)

**Do not use this script in an emergency or drill.
Use the log-in sheet on pages 4 through 7 of this script.
Write your call followed by NC (net control) by number 1.
Speed is important. Accuracy is paramount.**

QST, QST, QST. Good evening, and attention all amateur radio stations. This is the District 14 ARES® Southwest Unit Training Net. Your Net control Station this evening is _____, my name is _____ and I am located in _____. I will be using the tactical call sign Net Control. This net is currently meeting at twenty hundred local time here on the _____ MHz repeater located in Houston, Texas. The repeater output frequency is _____ MHz and the input is up / down 600. The repeater PL tone is _____. The back-up frequency is _____ up/down 600, PL tone_____.

This is an ARES® net for ARES® members. Any listening stations desiring additional information about this net are invited to contact the Net Control Station after the net secures. An opportunity for visitors to check in will be made available at the conclusion of this net.

This is a directed net and stations may not call other stations without first going through net control. Please do not use phonetics when calling Net Control. If I have difficulty copying you I will request phonetics.

(Let the repeater drop here. Don't over ID and remember to ID every ten minutes.)

Are there any stations wishing to check in, and out, at this time that are unable to remain on frequency for the duration of this net? Over **List the call signs of responding stations on your numbered check in sheet as they check in. Acknowledge: station call signs, or simply "roger".**

I will now call for ARES® officers. Following that roll call I will call for Southwest Harris County ARES® members. At the conclusion of the roll call for all ARES members, and after all other NET business has been concluded, I will call for visitor check-ins.
